My office received confidential grand jury information that was reviewed and considered in preparing the Amended Autopsy Report in this case. The Attorney General's Office has informed me that the Amended Autopsy Report therefore contains confidential information that is covered by the Court's Order and my Oath. My hands are tied and I am not permitted to release the Amended Autopsy Report unless and until I am released from the attached Order and Oath. The Attorney General's Office indicated that only the Denver Chief Judge could authorize release of the Autopsy Report. Once I have authorization from that Court to release the Autopsy Report, I will gladly do so.
